WAIVER, RELEASE OF LIABILITY, SOVEREIGN IMMUNITY, AND CONSENT FORM

I, the undersigned, do hereby: (1) give my full consent and approval to submit this entry form to participate as a contestant in the Gila River Indian Community's 61st Annual Mul-Chu-Tha Fair & Rodeo held on March 14–16, 2025 and within the exterior boundaries of the Gila River Indian Reservation; (2) acknowledge that the Gila River Indian Community ("Community") is a federally recognized Indian Tribe and that the departments and programs of the Community are tribal departments of the Community; and (3) Further, acknowledge that the Community, its Departments and programs are protected by the doctrine of tribal sovereign immunity, not subject to suit by the undersigned, and that the Community has not waived its sovereign immunity from suit with respect to any claims, demands, or causes of action asserted by the undersigned for any loss, damage, injury, including death, or negligence, which may have resulted from my participation in the above-referenced event(s).

In consideration of being allowed to participate in the Community's Mul-Chu-Tha All Indian Junior Rodeo, All Indian Masters Rodeo, All Indian Rodeo and Wild Horse Race, March 14–16, 2025, the receipt of such permission hereby acknowledged, I, the undersigned, hereby release, discharge, waive and relinquish the Community, its sponsors and volunteers from any and all liabilities, claims, or legal actions whatsoever arising out of or related to any loss, damage, or injury, including death which may be sustained by me or by any property in my possession or control, while in, on, or upon the premises and for participation I acknowledge and I am aware of: (1) the risks and hazards inherent upon entering said premises and/or participating in any of these events; (2) risks and dangers may exist that may be caused by the negligence of myself, or the stock contractor, or the employees, officers or agents of the Community and its Departments or Programs, of the negligence of others, accidents, breaches of contract, the forces of nature or other causes; and (c) the risks and dangers described above may arise from foreseeable or unforeseeable causes and by my participation in the above-referenced event(s).

I, the undersigned, hereby certify that I am the above named contestant, that I am 18 years of age or older, and that I have the capacity to enter into this Agreement, and I do hereby elect and voluntarily assume all risks of loss, damage, injury, and including death. I further certify that I am in sufficient health to participate in the above referenced event(s). I understand the dangers incidental to participating in these activities and the need for safety precautions. This release shall be binding upon me, my heirs, next of kin, executors and administrators and I acknowledge and represent that I have authority to execute this waiver.

I am also aware that these premises are alcohol and drug free, and I agree that I will not be under the influence of drugs or alcohol, which would impair my ability.

I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for negligent acts or other conduct by the officers, employees, administrators and volunteers of the Gila River Indian Community and for the operation of the Mul-Chu-Tha Fair and Rodeo.

I ACKNOWLEDGE THAT I HAVE READ THE ABOVE WAIVER, RELEASE OF LIABILITY, SOVEREIGN IMMUNITY AGREEMENT, AND CONSENT FORM, AND BY SIGNING I AGREE IT IS MY INTENTION TO EXEMPT AND RELIEVE THE GILA RIVER INDIAN COMMUNITY FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY NEGLIGENCE OR ANY OTHER CAUSE.
